#### **PURCHASING PRODUCT TANKERS**

(2,000 MT – 5,000 MT	completed sale of minimum 3 (three) tanker vessels with each 5,000 DWT or
carrying capacity)	above.
	c. Shipbrokers shall submit proof of sale of minimum 3 (three) tanker vessels
	with 5,000 DWT or above.
	d. Participation by joint ventures is not allowed. Only individual entities (Brokers
	or Owners) are authorized to submit Expressions of Interest (EOI) for
	consideration.

- b. The applicant shall submit their EOI via email to <u>tenders@sto.mv</u> clearly subjected "Purchase of a Product Tanker"
- c. Deadline for submission is 27th February 2024, 1600hrs, Maldives Time.
- d. STO may, at its discretion, extend this deadline for the submission of the EOI, in which case all rights and obligations of STO and applicants previously subject to the deadline will thereafter be subject to the deadline as extended.
- e. Any EOI received by STO after the deadline for submission of EOI will be rejected.
- f. The applicant may withdraw its EOI after submission, provided that written notice of the withdrawal is received by STO prior to the deadline for submission. No EOI may be modified after passing of the deadline for submission of EOI.
