  - b) Green screen space to do studio programs and set extension
  - c) Professional audio production equipment (hardware and software)
  - d) In-house equipment to do live streaming and experience in live streaming(STO shall conduct an inspection of the applicant's studio to verify criteria a-d)
- 1.4 At least (01) in-house or affiliated professional makeup artist
- 1.5 At least (01) in-house cinematographer
- 1.6 At least (01) in-house writers for copy writing and scripts
- 1.7 At least (01) in-house graphics designer familiar with latest versions of Adobe Creative Suite
- 1.8 At least (01) in-house music composer
